This approximates the mounting method of a typical ceiling baffle installation. The objects were distributed in three rows of three objects each, with rows spaced 76 mm (3 in.) apart, and objects in each row spaced 76 mm (3 in.) apart. 


Figure 1 – Specimen mounted in test chamber


