


Wide Rule & Wide Arc new deco pattern




Wide Arc vertical pattern




Wide Slant & Wide Rule stripe pattern




Double Arc organic pattern




Double Arc circles pattern




Multitrack madras pattern




Diamond vertical brick pattern









Wide Slant pinwheel pattern






